UEP to prepare and provide a costed and budgeted Business Plan to UTC (planning permission)

A monthly report on the project with updates and targets will be produced by UEP.

All requests for funds are to be in writing and provided in the first instance to me, Michael Fingleton (Jnr), upon approval payment will be made no more than 10 days later.
